

### **ABC House Valentine's Day Raffle Terms & Conditions:**

The Valentine's Day Raffle to benefit ABC House is conducted by ABC House, a non-profit organization under the laws of Oregon. The raffle is governed by the State of Oregon (OAR Ch 137 Div 25). By purchasing a raffle ticket, you agree to be bound by these rules.

1. The purchase price for one raffle ticket is \$50.00. A maximum of 300 raffle tickets will be sold. The raffle closes at 4:00 pm Pacific Time on Friday, February 2nd, 2026.
2. Ticket entries can be purchased online at [www.abchouse.org/raffle](http://www.abchouse.org/raffle) using a credit card. Each \$50.00 ticket will be one raffle entry.
3. All entry purchases are final and non-refundable.
4. Purchasers must be at least 18 years of age.
5. The name of the purchaser will be entered into the drawing to be selected at random. All 300 tickets have an equal chance of winning.
6. The winner of the raffle will be determined by random drawing. The drawing will take place on Wednesday, February 4th, 2026 at approximately 12:00 pm Pacific Time at ABC House, 228 SW 5th Ave, Albany OR 97321. The winner will be announced on the ABC House Facebook page and ABC House Valentine's Day Raffle page. Entrant(s) do not need to be present to win.
7. Winners agree to comply with all IRS regulations regarding raffle winnings.
8. The winner of the raffle is entitled to a dinner for two at the Sybaris Valentine's Day Dinner event, a necklace from Jordan Jewelers, and one bouquet of flowers per month for twelve (12) consecutive months from Steve Yutzie Floral, with each bouquet valued at up to \$75.00.
9. ABC House specifically disclaims all expressed or implied warranties. ABC House is not responsible for any losses or injuries suffered as a result of participation in the raffle or use of the prize.
10. The winner of the raffle must claim the prize within 7 days of the drawing. If the winner does not claim the prize within 7 days of the drawing, by responding to telephonic or written notice from ABC House or otherwise, the prize will be forfeited.

11. Purchasers of raffle tickets must provide their full names, addresses, email, and telephone numbers when purchasing the ticket online. If more than one name is stated, the first listed name shall be the Entrant. ABC House shall, will, and can have no obligation for payment or delivery of any prize to any person other than the Entrant. It is the sole responsibility of the entrant to allocate any such prize among the participants in any multiple-party entry.

13. Any and all disputes, claims, and controversies concerning this raffle shall be submitted to and resolved by binding arbitration, to be conducted under arbitration rules in the state of Oregon.

15. Raffle is void where prohibited.
