

### **Terms & Conditions:**

The Kona Vacation Raffle to benefit ABC House is conducted by ABC House, a non-profit organization under the laws of Oregon. The raffle is governed by the State of Oregon (OAR Ch 137 Div 25). By purchasing a raffle ticket, you agree to be bound by these rules.

1. The purchase price for one raffle ticket is \$50.00. A maximum of 200 raffle tickets will be sold. The raffle closes at 5:00 pm Pacific Time on Monday, February 28, 2022.
2. Ticket entries can be purchased online at [www.abchouse.org/kona](http://www.abchouse.org/kona) using a credit card. Each \$50.00 ticket will be one raffle entry.
3. All entry purchases are final and non-refundable.
4. Purchasers must be at least 18 years of age. At least one member of the winner's traveling party must be a responsible adult at least 21 years of age and have a valid credit card.
5. The name of the purchaser will be entered into the drawing to be selected at random. All 200 tickets have an equal chance of winning.
6. The winner of the raffle will be determined by random drawing. The drawing will take place on Tuesday, March 1, 2022 at approximately 12:00 pm Pacific Time at ABC House, 228 SW 5<sup>th</sup> Ave, Albany OR 97321. The winner will be announced on the ABC House Facebook page and ABC House Kona Raffle page. Entrant(s) do not need to be present to win.
7. Winners agree to comply with all IRS regulations regarding raffle winnings.
8. The winner of the raffle is entitled to a 7-night stay for up to four (4) people at the Kona Billfisher in Kona Hawai'i, arriving May 15, 2022 and departing May 22, 2022. At least one member of the winner's traveling party must be a responsible adult at least 21 years of age and have a valid credit card.
9. The winner of this raffle is entitled a \$500 travel voucher for travel on any airline serving Eugene Airport. Tickets are coach class and travel must occur before February 28, 2023. Reservations must be made no later than 21 days to travel. Non-transferable and subject to flight availability. May only be redeemed towards one round-trip airline ticket departing Eugene Airport.
10. Winner will assume and be responsible for all meals, tips, incidentals, car rental, preparation, and all other fees, and local, state, and federal taxes, including but not limited to all applicable sales, use, luxury, income, and special taxes associated with winning a raffle.

11. Winner agrees to pay the Hawai'i State Transient Tax: Transient tax from all guests and owners that check-in. This fee is based on a percentage of the value of the unit's annual maintenance fee. The fee has been calculated to be: 1 Bedroom: \$5.03 per night
12. ABC House specifically disclaims all expressed or implied warranties. ABC House is not responsible for any losses or injuries suffered as a result of the vacation prize.
13. Winner is responsible for obtaining accurate and up to date COVID-19 travel documents and requirements as required by the state of Hawai'i and the Eugene Airport. ABC House is not liable for COVID-19 restrictions.
14. The winner of the raffle must claim the prize within 7 days of the drawing. If the winner does not claim the prize within 7 days of the drawing, by responding to telephonic or written notice from ABC House or otherwise, the prize will be forfeited. After the prize is claimed, winner must abide by any restrictions placed on voucher by the issuing donor (e.g. expiration date for use).
15. Purchasers of raffle tickets must provide their full names, addresses, email, and telephone numbers when purchasing the ticket online. If more than one name is stated, the first listed name shall be the Entrant. ABC House shall, will and can have no obligation for payment or delivery of any prize to any person other than the Entrant. It is the sole responsibility of the entrant to allocate any such prize among the participants in any multiple party entry.

Purchasers of tickets, by participating in the raffle, release ABC House, its directors, officers, staff, volunteers and supporters from any and all liability, loss or claim arising out of any raffle prize, expressly waive any such claim and agree that the liability, if any, of ABC House, its directors, officers, staff, volunteers and supporters shall be limited to the raffle ticket price paid. ABC House makes no express or implied warranty as to the Raffle prize.
17. Any and all disputes, claims and controversies concerning this raffle shall be submitted to and resolved by binding arbitration, to be conducted under arbitration rules in the state of Oregon.
18. Prize is not redeemable for cash.
19. Raffle is void where prohibited.
