A LOOK BACK, WITH GRATITUDE

As you review the pages of this 2023 Annual Report, please know that this document is more than just a collection of statistics; it's evidence of the incredible impact made possible by your generosity! With each donation, you become a cornerstone in the foundation of our success, and we're excited to share with you the tangible outcomes your giving has made possible.

In 2023, your generosity enabled us to provide essential child abuse assessment services to 753 children and their families, marking another year of high demand. Each child served is a testament to the impact of your support. Children like the young boy who entered the ABC House lobby and made a bee line to the fish tank—and immediately began naming all the fish! Or the young girl whose eyes lit up as she entered the playroom and saw the “beach sand” at the beginning of her assessment appointment. Or the teenager who learned “belly breathing” in their trauma counseling session to help them cope with anxiety.

Your contributions have provided these children with the specialized care they need to heal and move forward from the trauma of abuse or neglect. Over the past year, this included 277 forensic medical exams, 487 medical consultations, 395 family support and referral sessions, 254 forensic interviews and 502 hours of trauma counseling sessions.

It also includes access to Xander, our Courthouse-Facility Dog, who had an exceptionally active year, offering vital emotional comfort to children and family members in crisis. From lending a furry presence during assessments to providing much-needed distraction, Xander's contributions, made possible through your support, help ensure that assessment appointments are a little easier for many children and families.

In tandem with our direct services, the ABC House Community Education Program made significant progress this past year, reaching more than 5,000 students, teachers, professionals, and members of various community groups with essential child abuse prevention training in 2023. With your ongoing support, we have scheduled numerous presentations this Spring, ensuring the continued impact of vital abuse prevention educational programming.

Looking ahead, your continued partnership is crucial as we move further into the new year with optimism and ambition. Together, we will pursue both short and long-term goals that will enhance our capacity to serve an even greater number of children in the months and years to come.

Thank you for being the driving force behind our achievements. Together, we have made a lasting difference, and we look forward to continuing this impactful journey hand in hand with you.

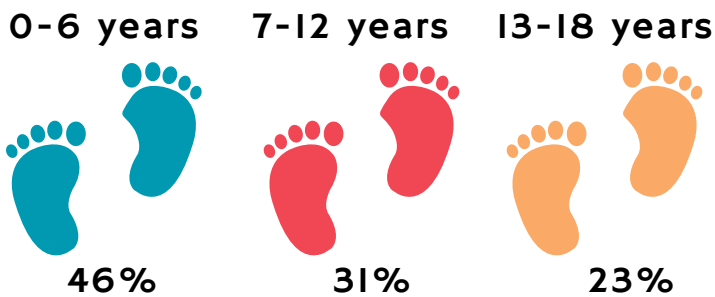

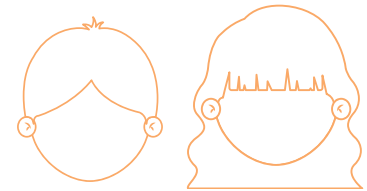

AGE

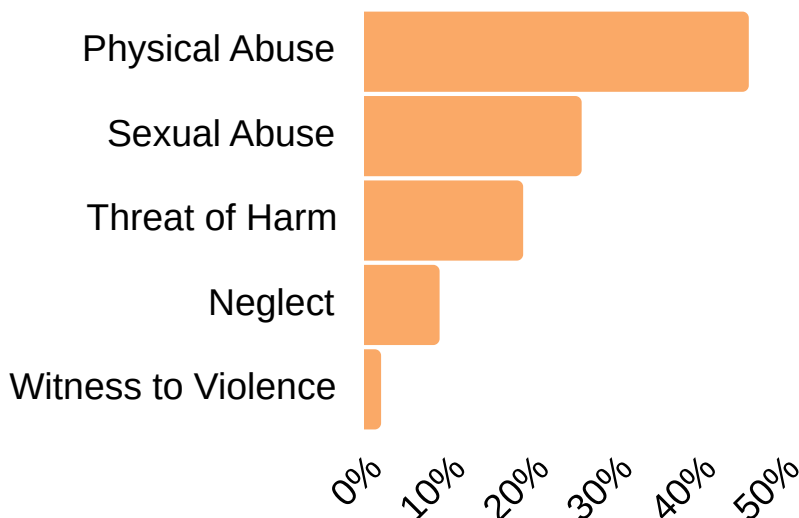


GENDER

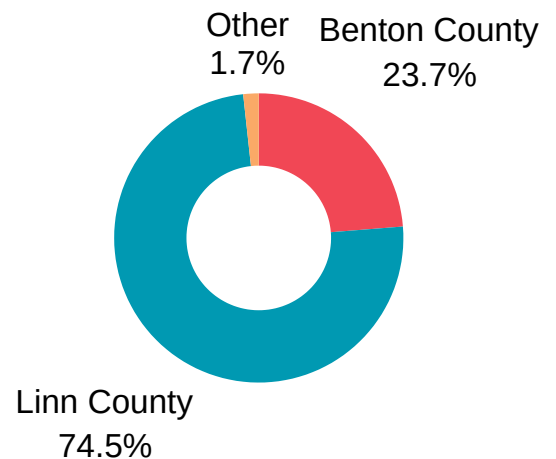

OUR SERVICES

Medical Exams & Consultations

Our medical providers are child abuse experts and remain supportive, objective, and neutral throughout the child's head-to-toe exam. Any physical signs of abuse are documented and may be used as evidence in the abuse investigation. Equally important, children have the opportunity to ask questions about how the abuse may have affected their bodies and development, and to receive reassurance from our trained staff.

792 Medical Services

Forensic Interviews

Forensic interviews are legally justifiable, fact-finding interviews with a child conducted by professionals trained in talking to children to obtain accurate and objective information. The purpose of a digitally recorded forensic interview is to reduce the number of times children need to share their experience.

Family Advocacy & Support Services

Families receive support to help them cope with the discovery of abuse and navigate at a time when their lives have turned upside-down. Our Advocates provide families with information to help non-offending caregivers understand the child abuse assessment and investigation processes, as well as connect them to any needed community resources.

395 Family Support Sessions

Trauma Counseling

ABC House counselors specialize in trauma treatment to help children and their family members process what has happened to them and move forward. Children learn strategies to help them manage their fear or feelings of being out-of-control when remembering abusive events, and to focus on their own strengths and abilities. These services are offered as long as they are needed.

Community Education & Prevention

As a leading voice on child abuse prevention and awareness, we believe that education is the key to ending child abuse. With a mission centered on breaking the cycle of abuse and neglect, ABC House offers a variety of in-person and online safety trainings to the public, free of charge. In 2023, we reached a new record of training over 5,000 children, youth and adults in Linn and Benton Counties through our community education program.

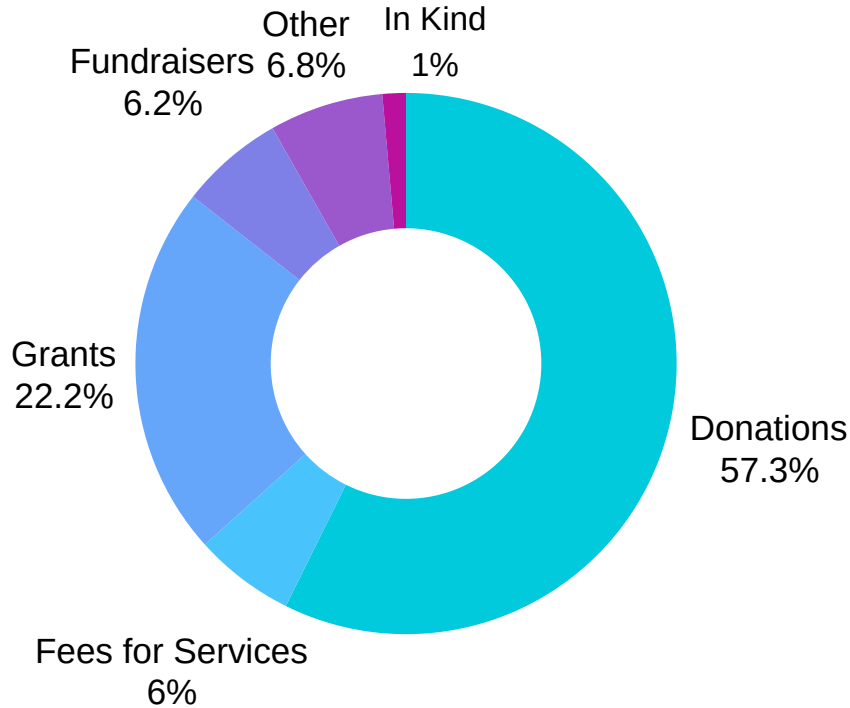

Financial Stability

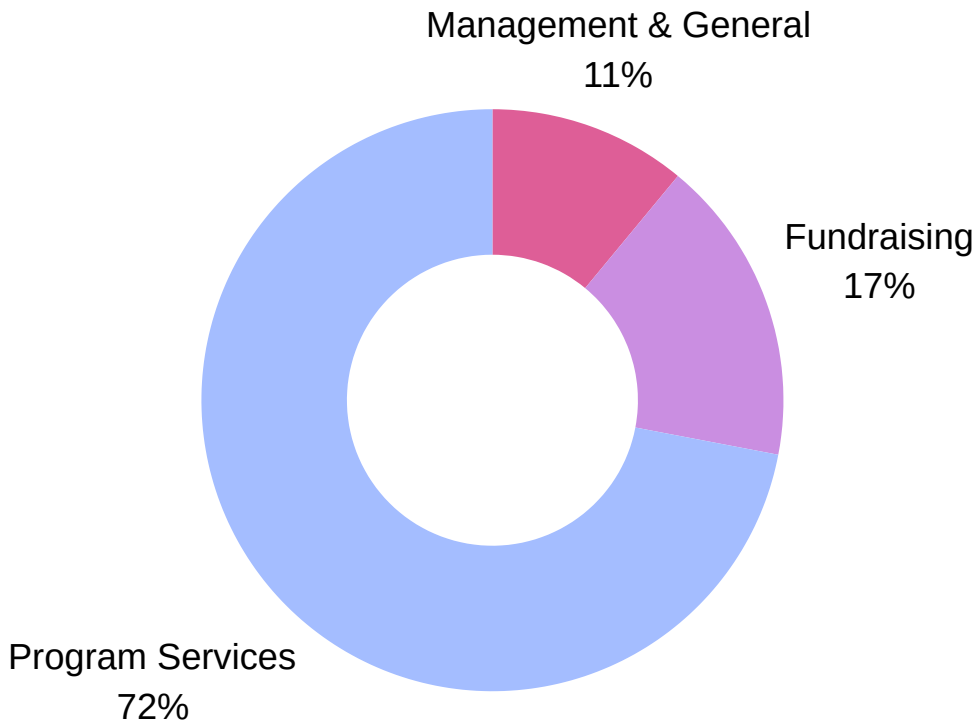
Because of your generosity, we are able to continue our mission of helping children in crisis. This is a snap-shot of our fiscal year July 2022 - June 2023.
