### ***Primary Responsibilities***

This position plays a key role on the ABC House child abuse assessment team by providing forensically-sound and evidence-based forensic interviews of children referred with concerns of child maltreatment. In addition, this position also provides awareness-raising trainings and presentations that empower community members to take active steps to break the cycle of child abuse and neglect. A strong focus for this position is engagement with the Hispanic/Latino community.

Principle Responsibilities include but are not limited to:

- Forensic interviewing
  - Provide forensically-sound and evidence-based forensic interviews (in English and Spanish) of children referred for concerns of child maltreatment, including gathering social history from client caregiver and preparation of final report.
  - Regularly participate in multidisciplinary team case review meetings.
  - Comply with lawfully-issued subpoenas and provide fact and expert witness testimony as required.
  - Participate in peer review and continuing education on a regular basis.
  - Maintain collaborative working relationship with multidisciplinary partners, including law enforcement and child protective services investigators.
- Community Education
  - Deliver presentations (in English and Spanish) on child abuse, mandatory reporting and other related issues for school district personnel, youth-serving professionals and volunteers, and the community at large.
  - Deliver presentations during the school year on child abuse, technology safety, and related issues.

- Build relationships with youth-serving organizations, faith communities, school district personnel, and parent groups, with an emphasis on the Hispanic/Latino community, in order to promote ABC House community education offerings.
- Track attendance and survey/evaluation data for presentations.
- Collaborate with local and statewide agencies and funding partners on child abuse prevention projects and initiatives, and represent agency at community fairs and other special events as needed.
- Other duties as assigned

### **Qualifications**

- Successful candidate will possess one of the following:
  - Master's degree in social work, psychology, child development or related field and two years of experience working with children;
  - Bachelor's degree and four years of experience working with children; or
  - Past employment as law enforcement officer or Department of Human Services child welfare worker.
- Fluent bilingual Spanish-speaker strongly preferred, bicultural preferred.
- Prior experience and training in forensic interviewing of children preferred.
- Demonstrated experience in building rapport with children and adults potentially impacted by trauma.
- Knowledge of child maltreatment issues, trauma in children, and trauma informed care, and strong research skills.
- Excellent verbal and written skills.
- Confident in public speaking and small group discussion, and comfortable discussing sensitive and difficult issues.
- Licensed, insured driver with access to reliable transportation.
- Ability to successfully complete criminal background check and child abuse registry check.

**Compensation:** Dependent upon experience. Excellent benefits package offered, including 100% employer-paid medical, dental and vision insurance for the employee, EAP program, paid holidays and a generous paid time off plan.
